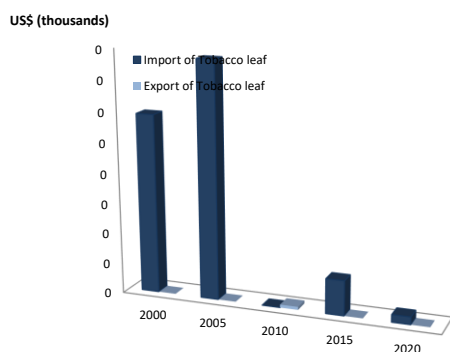

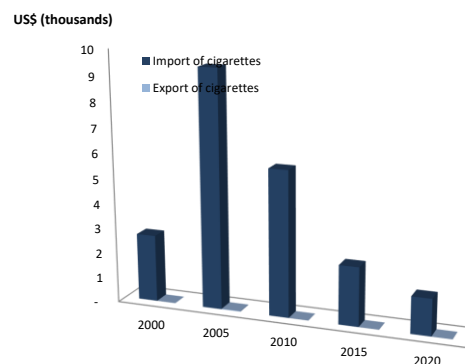

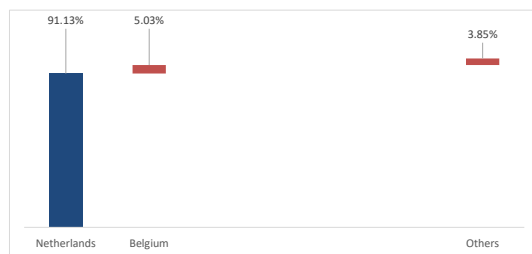

Cigarettes Trade



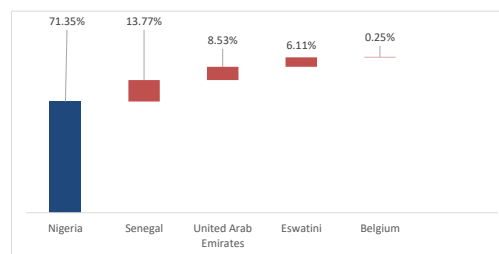
Tobacco Leaf Imports, 2015 (Countries of Origin)
