Join the WHO Global Knowledge Network for Health Equity (GKNHE) and the WHO Collaborating Centre on Health in All Policies and the Social Determinants of Health for a webinar on governance for health equity. This session will explore the role of governance in addressing social determinants of health, and how effective structures, participation, and policy coherence can be leveraged to reduce health inequities.

Context

In 2021, the Seventy-fourth World Health Assembly adopted resolution **WHA74.16** on addressing the social determinants of health. This resolution urged Member States to integrate SDH into public policies, adopt multisectoral approaches, and promote health equity and gender equality. It also tasked the WHO Director-General with fostering knowledge exchange among Member States and stakeholders on best practices in intersectoral action.

In response, WHO—with funding from the Public Health Agency of Canada—established the **Global Knowledge Network for Health Equity (GKNHE)** to support this mandate. This webinar is part of a series organized in collaboration with the WHO Collaborating Centre at Tampere University, focused on deepening understanding of the findings and recommendations of the WHO World Report on the Social Determinants of Health Equity (2025).

This session will emphasize **governance for health equity**—a core theme of the report. Governance determines how power, resources, and decision—making are structured and implemented across sectors that shape health outcomes. Good governance fosters transparency, public participation, and policy coherence—creating the enabling conditions to tackle health inequities. Under the action area of "Putting in place governance arrangements that will maximize the coherence and impact of action", the world report recommends to:

- Empower local governments to address health inequities;
- Support community engagement and civil society;
- Achieve universal health coverage through progressive health financing and primary health care approaches;
- Build and retain a health and care workforce capable of delivering equity;
- Strengthen focus on social determinants in health systems and policy platforms;
- Monitor social determinants of health equity.

About the webinar

This webinar will explore how governance structures, mechanisms, and practices impact health equity. It will highlight insights from the WHO World Report on the Social Determinants of Health Equity, with emphasis on governance as a foundational enabler for health equity-promoting action. Country case examples from Australia, Canada, and Saudi Arabia will illustrate how different regions are strengthening governance to embed equity into national policies and institutions. Their experiences will highlight both systemic challenges and innovative practices in governing for health equity.

Webinar objectives

- Understand the role of governance in addressing the social determinants of health and advancing health equity.
- Learn how countries are building governance structures that support multisectoral collaboration, accountability, and public participation.
- Explore practical experiences, challenges, and innovations from Australia, Canada, and Saudi Arabia.
- Engage with experts and country partners through a panel discussion and Q&A.
