Overall Management Response: Accepted

The recommendations presented in the evaluation of its Global WASH Strategy 2018–2025 are timely given the development of WHO's new General Programme of Work (GPW14) for 2025–2028 with its priority of climate and health, the emerging role of WHO in the new UN System-wide Strategy on Water and Sanitation, the need for a successor WHO WASH strategy beginning in 2026, and the ongoing Organization-wide process of prioritization in response to significant budget cuts. This evaluation has enabled reflection on achievements, identification of areas for improvement, and has provided a basis to inform the next WHO WASH strategy. The evaluation highlights the unique normative role of WHO through its WASH-related Guidelines as well as the organization's efforts on SDG monitoring, including WASH access and use and WASH-related Burden of Disease, country-level WASH systems strengthening, emergency response, and intersectoral collaboration with external partners. At the same time, it encourages further strengthening, alignment and integration of WHO WASH programming with priorities such as climate resilience, antimicrobial resistance, primary health care, infection prevention and control, and gender equality, disability, and social inclusion (GEDSI).

The evaluation acknowledges the benefits of strengthening and sustaining WASH capacity, particularly at WHO Country Offices while considering real-world restraints, including funding. Building on the achievements of the past years, WHO is committed to increasing the impact of its WASH programme through the development of a new WASH strategy that aligns with WHO's broader health objectives, integrates emerging priority areas, improves efficiencies, and ensures increased engagement at the regional and country levels, including through mechanisms that encourage accountability and integration of WASH and other health programmes.

This management response, already underway, was developed and agreed through a consultative process that engaged relevant Units and programmes at the headquarters and regional levels of WHO.

Recommendations and Action Plan

Recommendation 1: Develop a new WASH strategy based on WHO established core areas of work in WASH (including setting standards, guidelines, strengthening WASH systems at country level, monitoring, and promoting evidence-based policy and research), while integrating newly identified priority areas where WHO contributions add significant value (e.g. climate change resilience, WASH in emergencies including cholera, antimicrobial resistance, primary health care, infection prevention and control, vector-borne diseases, cholera, neglected tropical diseases, as well as GEDSI). The new Strategy should enhance intersectoral engagement and be aligned with both internal and external strategies of key WASH actors (including UNICEF), primarily the GPW14 and the UN System-wide Water and Sanitation Strategy.
