

Third meeting of the WHO Foodborne disease burden epidemiology reference group 2021-2024 (FERG2) Concept note and agenda

1. Background

Foodborne diseases are a major cause of human morbidity and mortality. According to the first-ever global estimates^{1,2} produced by the WHO Foodborne Disease Burden Epidemiology Reference Group (WHO FERG)³, foodborne diseases caused 600 million illnesses, 420 000 deaths, and 33 million Disability-Adjusted Life Years (DALYs) in 2010.

In 2021, 26 new members of the FERG were appointed with the specific terms of reference.⁴ The first two virtual meetings were held in July and October 2021, respectively. These two meetings situated FERG's work in the context of related WHO's work in food safety, including the Global Burden of Disease (GBD), global food safety strategy development and its monitoring and evaluation, its country support. FERG agreed on the governance and task force structures, roles and functions. Specific objectives, the scope of work and a workplan has been also discussed.

This third meeting is organized to reach an agreement on the concrete plan of actions towards 2025 reporting on the updated global estimates of the burden of foodborne diseases, and to advance a plan for country support activities as well as the development on the impact measurement framework.

2. Aim of the meeting

Finalize the 3-year strategic workplan for the FERG 2021-2024 on the following activities: 1) global estimation of the burden of foodborne diseases, 2) development and validation of global food safety indicators and targets, and 3) country support for estimating the national burden of foodborne diseases.

Specific objectives are to:

- 1. Share a progress update from all FERG taskforces and WHO
- Agree on the overall workplan and budgetary needs/priorities for the above-mentioned activities, including:
 - a. Final roadmap towards 2025 reporting on the updated global burden of foodborne diseases

- d. Advanced roadmap for country support
- e. Advance roadmap for developing the impact measurement framework
- f. Discuss required internal and external collaborations
- 3. Understand WHO's publication policy

- Plan for commissioning systematic reviews discussed and developed
