1. About the Observatory

The Global Observatory on Health R&D is a global-level initiative that aims to help identify health R&D priorities based on public health needs. It does so by consolidating, monitoring and analysing relevant information on the health R&D needs of developing countries; building on existing data collection mechanisms; and supporting coordinated actions on health R&D.

The Observatory aims to be a comprehensive source of information and analyses on global health R&D activities. It builds on existing data and reports from a wide range of data sources, gathering new information where needed and feasible.

The data contained in the Observatory's website (hereinafter, "Observatory Website") originates from sources both within WHO and outside WHO. The data is, in some cases, publicly available. In other cases it has been provided to WHO for use by the Observatory subject to certain conditions.

In many cases, data from original sources are reclassified according to standard classification categories and nomenclature in use by the Observatory to facilitate analysis and comparisons across data sources. The underlying standardized data used for analysis provided by the Observatory are available for download. Users wishing to use the original classification categories and nomenclature used by the data source should refer to the source directly.

Views or opinions expressed via the Observatory are those of WHO and do not necessarily reflect the views of the Observatory's data sources.

2. Your use of the Observatory Data and acceptance of these Terms and Conditions of Use

Your use of the Observatory and its contents (including its data and metadata) (hereinafter, "Observatory Data") is conditional upon acceptance and compliance with these Terms and Conditions of Use. By accessing or otherwise using the Observatory you agree to these Terms and Conditions of Use, and form an agreement (this "Agreement") with WHO.

In no event shall you use Observatory Data:

- a. In any manner which infringes the rights of any person or entity, including the rights of WHO and the attributed owner(s) of the Observatory Data;
- b. In, or in association with, any product marketing, promotional, or commercial activities, including, without limitation, in, or in association with, advertisements, product brochures, company-sponsored web sites, annual reports, or other non-educational publications or distributions;
- c. In, or in connection with, the promotion of a commercial enterprise and/or its product(s) or service(s), and/or in any way that suggests that WHO endorses any specific company or products;
