

# 2019 Novel Coronavirus (2019-nCoV) Emergency Readiness/ Response

Country: MALDIVES Date: 07 / 04 / 2021

### **Cases reporting**

- 24,783 confirmed cases have been reported till date.
- 1112 new cases have been reported since last week, and there are 3,075 active cases in the country currently more than 1,657 active cases are in the greater Male' region.
- One additional death was reported during the week and mortality rate 0.27% with 67 deaths.
- 665,413 samples have been tested till date. **Sample positivity rate** is maintained at **4%**. Cases continue to be seen more among **contacts** of positives and from departure samples from tourists and travelers.
- 941 new recoveries were reported during the week. 21,636 (87.30%) have recovered. 83 people are hospitalized with moderate to severe disease, 5 cases in ICU and 4 persons on ventilator care.
- There are currently **925** active cases across 65 **islands outside Male**. Cases are reported from **all the atolls** for the first time since outbreak in Maldives.
- In the central Kaafu atoll, two islands are reporting big clusters. In Kaafu Dhiffushi island, there are 105 active cases related to a quarantine release sample positive from a local. In Kaafu Huraa island, 134 active cases have been reported as positive cases.
- In Lhaviyani atoll, in the industrial island of Felivaru, there are over 254 positive cases reported to date. In the neighboring islands of Hinnavaru as well as Naifaru within the atoll; there are 200 cases reported. The atoll is placed under monitoring for random sampling.
- In tourist establishments and operational resorts, a total of 444 cases have been reported from 99 resorts across the country with 202 staff and 242 tourists.

### **Developments/ activities carried out by Member State**

- Over 251,139 persons have been vaccinated in Maldives. Second dose with the COVISHIELD vaccination has also started since 3<sup>rd</sup> April 2021.
- The DGPH and Minister for Health has extended the State of Public Health Emergency for the 12<sup>th</sup> time, till May 2021.
- Since the first of April 2021, the DGPH lifted all the restrictive measures imposed on the greater Male' region. Wearing of Masks is still mandatory across all the islands.
- Local Council Elections are being planned in discussion with the HPA and HEOC; with travel between islands (except for travel from Male') allowed for voting purposes.
- The ministry of education has announced that Students of all grades in the Greater Male' Region have returned to schools, after a two-month suspension of school sessions due to the latest surge of COVID-19 cases in the Maldives.
- As of 01 April 2021, total spending towards COVID-19 health and social efforts stood at MVR 1,611.7 million; a 3.0% increase from the week before. In this review period, 43.3% of total health and social spending was committed spending.
- Over 100,000 tourists visited the Maldives over the past month, statistics have shown; the first time the tourist arrivals exceeded 100,000 after the country reopened its doors to tourists following border closure.

#### **WCO** activities



- WHO continues to monitor the vaccination sites and is actively involved in deliberations of the National Vaccine Steering Group and Operations Group.
- Support to MNU for developing short term Field Epidemiology Training Programme (FETP) for Maldives.
- Technical Consultancy to Develop Guidelines and Training Programmes for the Methadone Maintenance Treatment.
- Supporting IPC Measures: such as ongoing efforts to monitor the vaccination sites for IPC related support.
- Supported ToT Training on clinical management of Hepatitis B and C which was conducted for physicians.

- Supported country presentation to MOH on technical briefing on Small States for Members of the Commonwealth Secretariat Board of Governance on COVID-19 vaccine roll out.
