

**Global Youth Tobacco Survey
Ecuador (Rest of country)
2024 Fact Sheet**



The Global Youth Tobacco Survey (GYTS), a component of the Global Tobacco Surveillance System (GTSS), is a global survey for monitoring youth tobacco use and tracking key tobacco control indicators. GYTS is a cross-sectional, nationally representative school-based survey of students that uses a standard core questionnaire, sample design, and data collection protocol.

The 2024 Ecuador (Rest of country) GYTS was a school-based survey of students in 9^o – 1^o (typically attended by students aged 13–15 years). A two-stage cluster sample design was used to produce data representative of all students in 9^o – 1^o in Ecuador (Rest of country). At the first stage, 30 schools were selected with probability proportional to enrollment size. At the second stage, classes were randomly selected and all students in selected classes were eligible to participate.

The Ecuador (Rest of country) GYTS measured any tobacco use, smoked tobacco, smokeless tobacco, susceptibility, electronic cigarette use, cessation, second-hand smoke, access and availability, tobacco advertising and promotion, anti-tobacco advertising and promotion, and knowledge and attitudes. Students self-reported their responses to each question on a computer scannable answer sheet.

The school response rate was 100%, the student response rate was 85.1%, and the overall response rate was 85.1%. A total of 1548 students participated in the Ecuador (Rest of country) GYTS of which 1342 were aged 13–15 years. Weighted prevalence estimates (percentages) and 95% confidence intervals are presented below.
