Validate cross-border actions aimed at eliminating NTDs in the following specific areas:

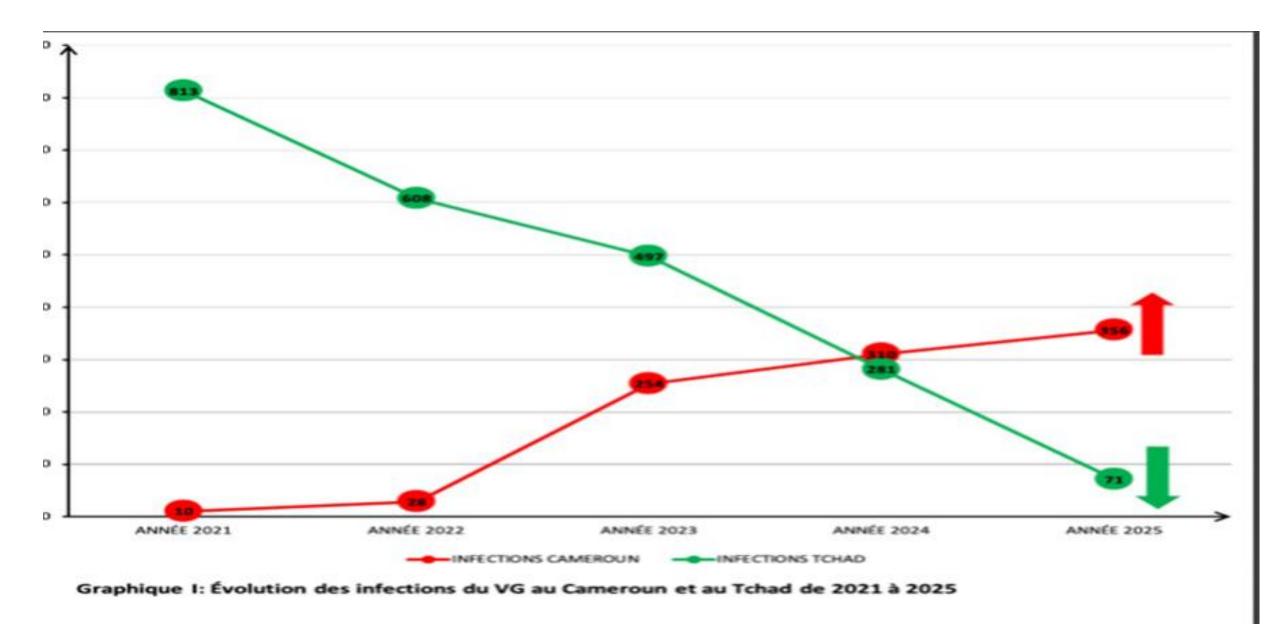
#### **Priority areas**

- ✓ Synchronisation of disease eradication interventions on both sides of the border,
- ✓ Sharing data from neighbouring districts,
- ✓ Use of existing expert committees and forums (e.g., One Health approach) on NTDs as platforms for regular exchange and coordination of cross-border collaboration activities,

#### Priority areas (continued)

- ✓ the integration of cross-border collaboration on NTDs into existing health collaboration memoranda of understanding,
- ✓ Facilitation of the safe and free movement of joint cross-border health teams, supplies
  and field equipment when needed.
- ✓ Collaborating on advocacy and awareness-raising by mobilising resources, including technical support and logistical arrangements, to support cross-border activities.
- ✓ assume overall responsibility, ownership and leadership for the implementation of crossborder collaboration activities to achieve disease elimination.

# Dr Salissou Adamou Coordinator of the National Filariasis and Onchocerciasis Control Program in Niger

#### BACKGROUND

- Several countries moving towards elimination of NTDs
- ➤ Given the persistence of transmission in some countries
- ➤In view of the objectives of the WHO recommendations, which encourage countries to eliminate at least one NTD by 2030
- Therefore, to preserve the gains made, a memorandum of understanding covering all NTDs between bordering countries is an absolute necessity.

#### OBJECTIVE OF THE MEMORANDUM OF UNDERSTANDING

- ✓ Strengthen cross-border collaboration for the elimination of NTDs.
- ✓ Ensure the implementation of synchronized interventions,
- ✓ Ensure data sharing and joint planning between neighboring countries.
- ✓ Align efforts in line with regional and global frameworks (e.g. WHO roadmap, CDC Africa, Agenda 2063) for NTDs.

#### **MOU** areas of collaboration

- •Coordinate efforts in cross-border regions through joint planning and implementation of interventions (MDA, monitoring).
- Coordinate cross-border activities by setting up focal points or coordination committees.
- Regularly exchange data on cross-border activities between countries to inform decision-making.
- Synchronize cross-border interventions to improve quality (coverage rates, completeness, etc.).

#### **MOU** areas of collaboration

- •Strengthen cooperation in resource mobilization, intersectoral collaboration under the "One Health" approach and research initiatives,
- •Facilitate the cross-border movement of joint health teams and the pooling of logistics and field equipment, to ensure rapid and effective implementation.

#### PRINCIPLES AND COMMITMENTS

Multi-sectoral coordination and country ownership.

Integration of efforts to combat NTDs into broader health and development objectives.

Recognition of NTD elimination as a high-return investment (e.g., \$25 for \$1 investment).

Commitment to equity, universal health coverage and sustainable development.

Period of validity is until elimination, with biennial reviews and the possibility of extension.

Can be revised by mutual consent to strengthen collaboration.

The protocol does not entail any financial commitment on the part of signatory countries;

Other countries or organizations may join with the agreement of the current signatories.

## Memorandum of understanding: Objective & areas of cross-border collaboration (1/3)

#### Context:

- > Onchocerciasis is a major public health problem in the cross-border areas of the Republic of Guinea, the Republic of Guinea, the Republic of Mali and the Republic of Senegal;
- > Shared transmission zones on both sides of their national borders;
- > Status of onchocerciasis;
- ✓ Senegal in post-treatment border surveillance
- ✓ Risk of recrudescence or reinfection of regions or zones where transmission has been interrupted/eliminated.
- > Elimination of onchocerciasis across borders coordinated and concerted approach between countries.

#### Main objective:

Establishment of a collaborative framework between signatory parties to strengthen onchocerciasis control and elimination in cross-border areas through joint and coordinated interventions.

## Memorandum of understanding: Objective & areas of cross-border collaboration (2/3)

#### **Areas of collaboration:**

#### Scope and cooperation

- √ implementation of harmonized and synchronized treatment strategies across borders
- ✓ establishment of a platform for cross-border onchocerciasis surveillance and joint monitoring of progress towards elimination through onchocerciasis epidemiological and entomological data and impact assessments;

#### Implementation mechanisms and responsible authorities

- ✓ Commitment of the Ministries of Health of Guinea, Guinea Bissau, Mali and Senegal designated as the authoritative bodies responsible for the execution of this MoU;
- ✓ A cross-border coordination committee will be set up to oversee the implementation of this MOU;
- ✓ Organization of regular meetings between senior officials and technical experts of the parties to ensure proper implementation of agreed activities.

## Memorandum of understanding: Objectives & areas of cross-border collaboration (3/3)

#### Responsibilities and procedures

- √ Alignment of activities with national onchocerciasis elimination strategies and WHO guidelines;
- √ Regular exchange of treatment plans and progress reports;
- ✓ Collaboration in advocacy and awareness-raising, resource mobilization, including technical support, and logistical arrangements, to support cross-border activities.

#### Monitoring and data sharing

- ✓ Joint implementation of surveillance activities in border areas;
- √ Sharing of collected data between countries, regional health organizations and donors;
- ✓Organization of joint monitoring and evaluation exercises;
- ✓ Establishment of a common data repository to monitor elimination progress in cross-border areas.

#### **Commitments of the parties**

- ✓ Respect and implement jointly defined strategies for the elimination of onchocerciasis;
- ✓ Mobilize the necessary resources for the effective implementation of planned actions;
- ✓ Ensure the sustainability of actions through integration into national public health programs.

## Memorandum of understanding: challenges / approval process & benefits

#### **Challenges and solutions:**

- ❖ Absence of a Memorandum of Understanding (MOU) for cross-border collaboration for the sustainable elimination of onchocerciasis draft MOU developed in March 2025 and submitted for approval
- ❖ Validation of the final version of the MOU September 30, 2025 deadline for all countries involved

#### Advantages & Benefits for a crossborder AP

- ❖ For a country to be able to verify the elimination of onchocerciasis transmission, it must demonstrate that cross-border collaboration has been undertaken and that it has led to the elimination of cross-border transmission foci.
- ❖ strong, effective and active cross-border coordination is needed to prevent any recrudescence or reinfection, in order to achieve the goal of eliminating Onchocerciasis transmission
