### **Dr Keith Sumption**

Keith Sumption is Chief Veterinary Officer of Animal Production and Health Division (AGA) at the Food and Agriculture Organisation of the United Nations (FAO). He served as Executive Secretary of the FAO where he led the development of the Progressive Control Pathway which has become part of many of major global initiatives for zoonotic diseases. He has also been involved in one of the largest training programmes, with trainees from around 100 countries.

# **Matthew Stone**

Matthew Stone is a veterinary epidemiologist and Deputy Director General – International Standards and Science at the World Organisation for Animal Health (OIE). He has robust veterinary practice, and has served in numerous management roles, including as the New Zealand Delegate to the OIE. At OIE Matthew oversees the organisation's processes for setting international standards, including global strategies for foot and mouth disease, rabies, animal welfare and antimicrobial resistance.

### **Anand Kumar**

Anand Kumar is Managing Director at Indian Immunologicals Ltd - a subsidiary company of National Dairy Development Board and one of the largest producers of human and animal vaccines in India. Dr Kumar has worked for more than a decade outside India for companies such as Pfizer Global Manufacturing in Australia and Schering Plough Animal Health in New Zealand. He also served as an expert volunteer with United States Pharmacopeia during the period 2010-15. He has been a speaker at various international forums.

#### **Edmundo Larrieu**

Edmundo Larrieu is Professor at the Department of Epidemiology and Public Health Faculty of Veterinary Sciences of the Universidad Nacional de la Pampa and at the Universidad Nacional de Rio Negro, Argentina. He is also Vice President of the International Association of Hydatidology for the Americas. He has published extensively, with more than 60 scientific papers published in peer-reviewed journals and is the recipient of many prestigious awards.

### **Wendy Harrison**

Wendy Harrison trained as a veterinarian and has worked in academia, the pharmaceutical industry and international development always at the interface of animal and human medicine. She is currently the CEO at the SCI Foundation who support endemic country governments with NTD control measures and advocates multi-sectoral approaches. Wendy is a Past chair of the NTD NGO Network is currently Chair of the One Health cross cutting working group on whose behalf she is presenting.

### Sanjib Kumar Sharma

Sanjib Kumar Sharma is Professor and Head of the Department of Internal medicine at BP Koirala Institute of Health Sciences, Nepal. Dr Sharma is involved in several international research collaborations and has worked in developing guidelines for snakebite. He has more than 20 years' experience in snakebite management and research and has published 30 papers in international journals. He was among those who established the Snakebite Treatment Center in Nepal, currently managed by paramedics.

## Afif Ben Salah

Afif Ben Salah is Vice Dean for Graduate Studies and Research, Arabian Gulf University, Kingdom of Bahrain. Professor Ben Salah is also Professor of Community Medicine at the Department of Preventive Medicine and Epidemiology, Medical School and Institut Pasteur in Tunis. He is recognized for his work in leishmaniasis epidemiology and public health. Since 2016, he is associated with the Arabian Gulf University where he chairs the Family and Community Medicine Department.

# **Steve Lindsay**

Steve Lindsay is an entomologist and is involved in the development of new tools to reduce the transmission of vector-borne diseases. Professor Lindsay has studied vector-borne diseases for nearly 35 years and has worked in many countries. More recently, his team demonstrated that larval control can be an extremely effective method of malaria control in specific situations. He was also part of a team that demonstrated that trachoma, a leading infectious cause of blindness, is transmitted by the face fly, *Musca sorbens*. He is a strong advocate of integrated vector management and works closely with Roll Back Malaria and WHO.

### **Emmanuel Chanda**

Emmanuel Chanda is a Medical Entomologist and Vector Control Specialist at WHO's Regional Office for Africa in Brazzaville. Dr Chanda has worked in areas such as entomological surveillance, planning, implementation, monitoring and evaluation of vector control policies, strategies and tools in the context of integrated vector management. He is passionate about strengthening the control and elimination of vector borne diseases within the framework of the Global Vector Control Response.

#### Ashwani Kumar

Ashwini Kumar has more than three decades of research experience in vector borne diseases and is currently the Director of Vector Control Research Centre at the Indian Council of Medical Research. Among the major operational projects includes demonstration of malaria epidemic control in Goa and Vector Control in Goa Port using bio-engineering methods. Dr Kumar has published widely and believes in quality research through networking and team building.

# **NG Lee Ching**

NG Lee Ching is Director of National Environment Agency's Environmental Health Institute, Singapore. Professor Ng spent 20 years contributing to building laboratory capability for Singapore's public health and developing tools and strategies for mitigation of risks. She also serves as Advisor to WHO for dengue and chikungunya surveillance and control and is Director of the WHO Collaborating Centre for Reference and Research of Arbovirus and their Associated Vectors.

Since 2012 he sits as a Crossbench, or independent, peer in the House of Lords. He is only the second veterinary surgeon to become a member of the House of Lords after Lord Soulsby.

Victoria Goodfellow is Executive Director, Lion's Head Global Partners and has extensive experience in the design and execution of financing solutions in emerging markets, with a focus on the sustainable development of low-income countries. Before specialising in the health sector, Ms Goodfellow spent a decade in investment banking at Barclays, Citigroup and UBS, in senior positions providing advisory and execution services to institutional investors in emerging and frontier equity markets, with expertise in South Africa, Russia, and the Middle East.

## **Daniel Eibach**
