#### News

### Trans fat elimination validation award at WHA78

On 19 May 2025, WHO <u>recognized four countries</u>—the Republic of Austria, the Kingdom of Norway, the Sultanate of Oman and the Republic of Singapore—for their outstanding efforts in eliminating industrially produced trans fats from their food supplies. The validation certificates for 2025 were presented by the WHO Director-General Dr Tedros Adhanom Ghebreyesus during the Seventy-eighth World Health Assembly (WHA78).

These countries have successfully implemented WHO recommended best-practice policies alongside rigorous monitoring and enforcement systems. More information about the Validation Programme here.



## Extension of the comprehensive implementation plan on maternal, infant and child nutrition to 2030

WHA78 passed a <u>resolution on tackling</u> <u>malnutrition in mothers, infants and young</u> <u>children</u>, reaffirming global commitments to maternal and child nutrition and health. Member States agreed to extend the Global Nutrition Targets from 2025 to 2030 and adopt <u>new process indicators</u> to monitor progress. In addition, more ambitious goals were set for targets that have nearly been achieved. Read more here.



## Country consultation on the 2025 edition of the global burden of foodborne diseases

On 16 June 2025, WHO launched the first formal Country Consultation on national-level estimates of the global burden of foodborne diseases, sharing preliminary estimates with Member States for review. The WHO Foodborne Disease Estimates 2025 are aimed to be published later this year. For the first time, these estimates will provide data at the national level. More information here.


#### Resolution on the regulation of the digital marketing of breastmilk substitutes

Countries at WHA78 also adopted a resolution on regulating the digital marketing of breast-milk substitutes and agreed to extend the provisions of the International Code of Marketing of Breast-milk Substitutes (the Code). It aims to protect infant and child health from aggressive digital marketing practices by the baby food industry.



#### Collaboration with Nanyang Technological University on New Approach Methodologies

launched NFS three-year а new Nanyang collaboration with the Technological University (NTU) Singapore, aimed at modernizing food safety risk assessment. The collaboration will support countries in addressing novel food categories (cultured meat, functional foods, precision-fermented products and other) through integrating cutting-edge techniques such as artificial intelligence (AI) and digital modelling.

# Ad hoc FAO/WHO expert meeting on water quality in agrifood systems and food safety implications – focus on chemical contaminants

This meeting report of the WHO expert consultation, held on 19 and 22 September 2023, provides revisions of the WHO reference protocol for measuring trans fat in foods with up-to-date, comprehensive and validated options for conducting analysis.

#### **Salt Awareness Week**

On the occasion of the Salt Awareness Week (12-18 May 2025), WHO led an awareness-raising campaign about the use of lower-sodium salt substitutes (LSSS) as one tool in sodium reduction as a public health intervention, in collaboration with Resolve to Save Lives, Bloomberg Philanthropies and Global Health Advocacy Incubator. #### **Health Talks on Food Safety**

On 2-4 June 2025, WHO is hosted Health Talks on Food Safety to mark the occasion of World Food Safety Day. A series of three webinars highlighted how science drives progress in food safety, advice, foodborne covering expert disease burden estimation, surveillance, and laboratory systems global collaboration, and featured leading voices from WHO and partners. #### 100th JECFA meeting

The Joint FAO/WHO Expert Committee on Food Additives (JECFA) has been active since 1956 and this year celebrated its 100th meeting in Rome, Italy, on 10 - 19 June 2025. A paper to mark this occasion was published in Regulatory Toxicology and Pharmacology, Contributions of the joint FAO/WHO expert committee on food additives to international food safety: celebrating the 100th meeting of the committee.



#### **Asia-Pacific Total Diet Study workshop**

The Ministry of Food and Drug Safety of the Republic of Korea and WHO jointly hosted the first Asia-Pacific Total Diet Study (TDS) workshop on 18-19 June in Seoul. It brought together representatives from 24 countries across the region. Participants shared TDS methodologies, findings and insights of their own countries to promote regulatory alignment and strengthen food safety governance. Next steps include mapping capacities and needs across the region and mobilizing resources to support TDS implementation and harmonization.



### New Approach Methodologies in future food safety risk assessment

A webinar held on 20 June presented key international outcomes from an workshop on NAMs organized by WHO Nanyang Technological and the University Singapore. It offered insights from experts as well as strategic recommendations for the integration of NAMs into contemporary food safety risk assessment frameworks. Watch the recording here.



#### **Nutrition and food safety events at WHA78**

A <u>number of side events at WHA78</u> (19–27 May 2025) focused on nutrition and food safety topics, including (clockwise from top-left): human rights in action on obesity and NCDs; implementation of large-scale food fortification (LSFF); future of school nutrition; action to achieve the Global Nutrition Targets by 2030; ultra-processed foods and the role of front-of-pack labelling in promoting healthier diets; and country progress as part of the WHO Acceleration Plan to Stop Obesity.
