High Level Implementation Plan III - Priority Country List (2026-27)

This list presents the countries prioritized for support in 2026-27, based on the criteria outlined in Annex 4 of the PIP Framework Partnership Contribution (PC) High-Level Implementation Plan III (HLIP III). Under Outputs 1 and 2 countries receive direct financing from the PIP PC as well as technical assistance to implement planned activities. Countries prioritized for Outputs 3 and 4 receive technical assistance and, as needed, indirect financing from WHO HQ or Regional Offices to conduct activities.

The full prioritization process was conducted in 2023, prior to the start of HLIP III implementation, and the list has been reviewed and updated for the 2026-27 biennium.

Whilst PIP Priority Countries are those specifically identified for financial and / or technical support at the start of the biennium, other countries may also benefit from the PIP PC through activities organized by the WHO Regional Offices.
