

GYTS Objectives

The Global Youth Tobacco Survey (GYTS), a component of the Global Tobacco Surveillance System (GTSS), is a global standard for systematically monitoring youth tobacco use (smoking and smokeless) and tracking key tobacco control indicators.

GYTS is a cross-sectional, nationally representative school-based survey of students in grades associated with ages 13 to 15 years. GYTS uses a standard core questionnaire, sample design, and data collection protocol. It assists countries in fulfilling their obligations under the World Health Organization (WHO) Framework Convention on Tobacco Control (FCTC) to generate comparable data within and across countries. WHO has developed MPOWER, a technical package of selected demand reduction measures contained in the WHO FCTC:



Monitor tobacco use & prevention policies

Protect people from tobacco smoke

Offer help to quit tobacco use

Warn about the dangers of tobacco

Enforce bans on tobacco advertising, promotion, & sponsorship

Raise taxes on tobacco

GYTS Methodology

GYTS uses a global standardized methodology that includes a two-stage sample design with schools selected with a probability proportional to enrollment size. The classes within selected schools are chosen randomly and all students in selected classes are eligible to participate in the survey. The survey uses a standard core questionnaire with a set of optional questions that countries can adapt to measure and track key tobacco control indicators. The questionnaire covers the following topics: tobacco use (smoking and smokeless), cessation, secondhand smoke (SHS), pro- and anti-tobacco media messages and advertisements, access to and availability of tobacco products, and knowledge and attitudes regarding tobacco use. The questionnaire is self-administered; using paper sheets, it is anonymous to ensure confidentiality.

In Mizoram, the GYTS-4 was conducted in 2019 as part of national survey by the International Institute for Population Sciences (IIPS) under the Ministry of Health and Family Welfare (MoHFW). The overall response rate for Mizoram was 66.9%. A total of 1,404 students from 21 schools (Public-10; Private-11) participated in the survey. Of which, 913 students aged 13-15 years were considered for reporting.

GYTS-4 Highlights

TOBACCO USE

- 58% of students – 64% of boys and 53% of girls – currently used any tobacco products.
- 44% of students – 56% of boys and 3% of girls – currently smoked tobacco.
- 35% of students – 51% of boys and 22% of girls – currently smoked cigarette.
- 4.6% of students – 6.4% of boys and 3.0% of girls – currently smoked *bidi*.
- 33% of students – 28% of boys and 38% of girls – currently used smokeless tobacco.

CESSATION

- 52% of students – 63% of boys and 36% of girls – tried to quit smoking in the past 12 months.
- 53% of current smokers wanted to quit smoking now.
- 59% of current users of smokeless tobacco tried to quit using in past 12 months.
- 50% of current users of smokeless tobacco wanted to quit now.

SECONDHAND SMOKE

- 42% of students were exposed to tobacco smoke at home.
- 51% of students were exposed to tobacco smoke inside enclosed public places.

ACCESS & AVAILABILITY

- 58% of current cigarette smokers and 25% of current *bidi* smokers bought cigarettes/*bidis* from a store, *paan* shop, street vendor or vending machine.
- Among the current smokers who bought cigarette/*bidi*, 81% of cigarette smokers and 83% of *bidi* smokers were not refused because of their age.

MEDIA

- 57% of students noticed anti-tobacco messages in the mass media.
- 17% of students noticed tobacco advertisements or promotions when visiting points of sale.

KNOWLEDGE & ATTITUDES

- 84% of students thought other people's cigarette smoking is harmful to them.
- 86% of students favoured ban on smoking inside enclosed public places.

SCHOOL POLICY

- 95% of school heads – 100% in rural and 92% in urban schools – were aware of COTPA, 2003.
- 81% of school heads – 89% in rural and 75% in urban schools – were aware of the policy to display 'tobacco-free school' board.



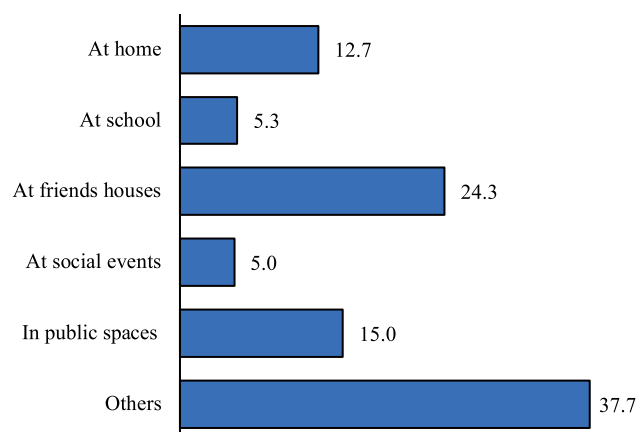

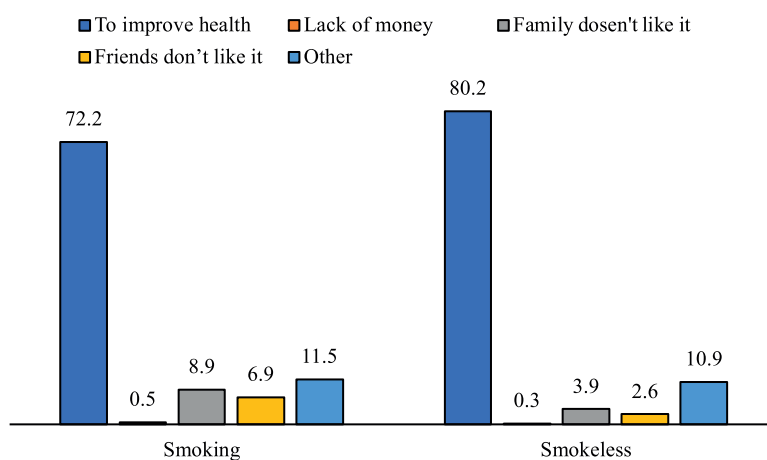
