

TERMS AND CONDITIONS

Comic and Illustration Competition “Women and COVID-19”

By entering in this Competition, you agree to the below Terms and Conditions:

ARTICLE 1: Objective of the Competition

- 1.1** The Competition is organised by UN Women, WHO and the Ministry of Women Empowerment and Child Protection (collectively “the Organising Entities”). The competition aims to increase awareness and spark a conversation on the impact of the COVID-19 pandemic from the perspective of women and girls in Indonesia.
- 1.2** All entries to the Competition must demonstrate how women’s lives have changed during the pandemic and how women are playing a central role in preventing the spread of COVID-19 and keeping their families and communities safe and resilient.
- 1.3** All entries must be inspired by the theme as referred to above. Entries deviating from the above shall automatically be disqualified.

ARTICLE 2: Terms of participation

- 2.1** Entry is open to Indonesia nationals age 15-24 for Category I and 25 and above for Category II.
- 2.2** Entry to the competition is free. You may enter up to two drawings but only one prize per person will be awarded. You must enter all of your drawings at the same time. You can only enter your drawing(s) once.
- 2.3** You can send in either comic(s) or illustration(s).
- 2.4** You must submit your drawing(s) by midnight (24:00 WIB) 15 November 2020 at the latest. Late entries will not be accepted. Drawings should be submitted by email to: info.indonesia@unwomen.org. You *must* mention “Kompetisi Komik dan Ilustrasi” and competition category in the title of your e-mail. Due to the expected high volume of last-minute entries, we advise you to enter your drawing(s) well in advance of submission deadline. The organising entities cannot be held responsible for possible delays and/or errors by e-mail.
- 2.5** Together with the drawing(s), you must submit a detailed caption (no more than 100 words) linking the artwork to the main theme of women and COVID-19, a copy of an ID or student card, and contact number.
- 2.6** If you receive a notification e-mail from the Organisers, you must respond to the notification e-mail to accept your prize. If the Organisers do not receive a response from you within seven days of the notification, the Organisers reserve the right to reallocate the prize to another participant.
- 2.7** Names of the prize winners will be publicly announced at a virtual award ceremony on 9 December 2020. The prizes are set out below:
 - 1st prize winners: Tablet + goodie bag + Certificate of Recognition.
 - 2nd prize winners: Digital drawing tool + goodie bag + Certificate of Recognition.
 - 3rd prize winners: Sketching and drawing set + goodie bag + Certificate of Recognition.
 - People’s Favourite: Surprise goodie bag.
- 2.8** The decisions of the jury are final and binding. Criteria assessed are: relevance to the theme; technique; composition. People’s Favourite winner will be chosen based on a polling in UN Women Indonesia Facebook Page and jury’s selection based on the criteria.
- 2.9** The Organising Entities reserve the right to cancel, modify, suspend or delay the Competition in the event of unforeseen circumstances beyond their reasonable control. The Organising Entities reserve the right to change, amend, delete or add to these Terms and Conditions at any time.

- 2.10** The Organising Entities and their officials and agents shall not be responsible or liable for any claims, demands, losses and liability of any kind or nature arising out of or in connection with your participation in this Competition or your acceptance or use of the prizes awarded.
- 2.11** The participants drawings may be considered for exhibition as well as for further publication.

ARTICLE 3: Eligibility of participants and drawing

3.1 Eligibility of participants

- 3.1.1** You must be at least 15 years old (Category I) and 25 years old (Category II) on 16 October 2020.
- 3.1.2** You must be an Indonesian nationals.
- 3.1.3** You must provide a copy of your ID or student card – which indicates your age/date of birth and residence – when submitting the drawing(s) along with contact number.

3.2 Eligibility of drawing(s)

- 3.2.1** The drawing(s) must not include words.
- 3.2.2** Your drawing(s) must fit on one DIN A4 page (210mm x 297mm). Both portrait and landscape orientation are accepted. If a drawing comprises several pictures, the number of the pictures should not exceed six boxes and the complete drawing must fit on one DIN A4 page.
- 3.2.3** The resolution of the drawing(s) must be 150 dpi or higher. Data size is limited to 20 MB per drawing. We accept jpg, jpeg, png, and pdf formats.
- 3.2.4** Your drawing(s) must not in the determination of the Organising Entities:
- Be disrespectful of the impartiality and independence of the United Nations;
 - Reflect adversely on the Organising Entities;
 - Be incompatible with the aims and objectives of the Organising Entities;
 - Be derogatory to any existing person depicted in the drawing(s);
 - Contain any nudity, lewd, or otherwise offensive content.
- 3.2.5** The Organising Entities shall not be responsible or liable for: a) any problem, loss or damage due to delay and/or failure in receiving and sending the entry as a result of any network, communication or system interruption or error, or b) any error, interruption, deletion, defect, delay in operation or transmission, or unauthorised access to entries.
- 3.2.6** Submitted drawing(s) must be original, unpublished work. Entrants represent and warrant that their Submission is their original work, it has not been copied from others, and it does not violate the rights of any other person or entity.
- 3.2.7** Incomplete entries or entries that do not comply with these Terms and Conditions will be automatically disqualified at the sole discretion of the Organising Entities.

Article 4: Copyright

- 4.1** All Competition entries become the property of the Organising Entities and will not be acknowledged or returned. The copyright in any submitted drawing(s) shall remain the property of the entrant, but entry in this Competition constitutes entrant's irrevocable, perpetual permission and consent to the Organising Entities and others authorized by the Organising Entities without further compensation or attribution, to use, distribute, reproduce, re-exhibit or otherwise utilize the Submitted drawing(s) in whole or in part, and the entrant's name and city and state, by any means or methods now known or hereafter devised in any and all media now in existence or hereinafter created, throughout the world, for the duration of the copyright in the drawing(s). The entrant also consents to the Organising Entities doing (or omitting to do) any acts in respect of the submitted drawing(s) which may otherwise constitute an infringement of the entrant's rights. Organising Entities and/or others authorized by the Organising Entities shall have the right to edit, adapt, and modify the submitted drawing(s). No compensation will be paid to the artist in case of the publication of the competition entry.

Article 5: Indemnification

- 5.1** By entering your drawing(s) in the Competition you agree to indemnify, defend, and hold and save harmless, the Organising Entities, and its officials, agents, employees, consultants, sub-contractors and other representatives from and against all suits, proceedings, claims, demands, losses and liability of any kind or nature brought by any third party against Organising Entities, including, but not limited to, all litigation costs and expenses, attorney's fees, settlement payments and damages, based on, arising from, or relating to the Organising Entities' use of the drawing(s). The obligations under this section do not lapse upon closure of the Competition.
