WHO Thailand Situation Report – 4 April 2020

Data as reported by the Thai Ministry of Public Health on 4 April 2020

HIGHLIGHTS

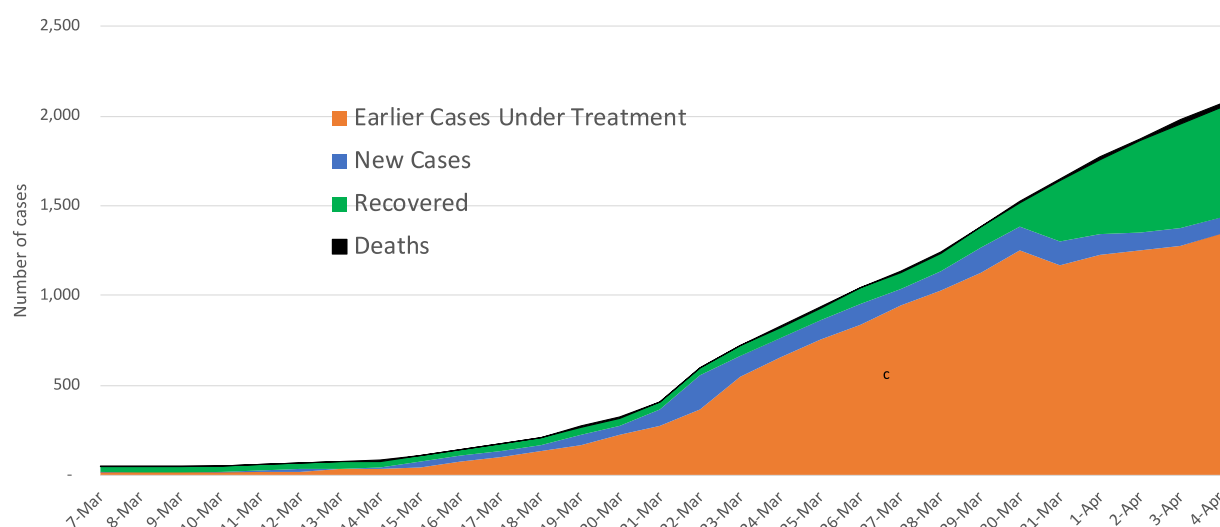
- On the 4th of April 2020, 89 new cases of laboratory-confirmed COVID-19 were announced by the Ministry of Public Health of Thailand, bringing the total number of cases to 2,067.
- Of the newly reported cases, 21 cases were identified in people entering or returning to Thailand, highlighting the need for strict compliance with quarantine requirements. The Thai Government has announced that between now and 15 April, Thailand will take steps to reduce the number of people entering the country.
- A total of 33 of the new cases are close contacts of previously confirmed cases, highlighting the need for strict adherence with social distancing in all settings. Cases are also still being reported in individuals whose work brings them into contact with large numbers of people, suggesting that further social distancing restrictions may be required.
- 64 of 77 provinces have now reported laboratory-confirmed cases of COVID-19. Approximately half of the cases to date have occurred in Bangkok and half have been detected in other provinces.
- 35 healthcare workers have been infected to date. To protect our healthcare workers and health system, it is essential that all of us remain inside our homes as much as possible, maintain a distance of at least 1.5 meters from other persons, wash our hands frequently and comply with the Thai government request for all persons to wear cloth face masks when in public spaces.

UPDATES FROM THE MINISTRY OF PUBLIC HEALTH IN THAILAND

- On April 3rd the Civil Aviation Authority of Thailand announced a [regulation](#) prohibiting all commercial flights from entering Thailand until April 6th. All returnees will be held in quarantine at a government approved hotel for 14 days.
- The government has announced a nationwide curfew beginning April 3rd. All residents are instructed to remain inside their homes between the hours of 10pm and 4am. Police have set up checkpoints across the country to closely monitor.
- The government requests that everyone wear a cloth face mask when outside their home.
- The government is preparing to use certain hotels as field hospitals. A total of 16,000 rooms from contracted hotels will be used for the isolation and care of mildly ill patients. Persons with adequate facilities in their homes (e.g. private room, separate bathroom) may be permitted to stay in home quarantine. The contracted hotels will be inspected according to criteria set by the MOPH.

ADVICE FOR THE PUBLIC



For the sake of our frontline health care workers it is crucial that we ALL maintain strict social distancing and other measures to reduce the spread of COVID-19.

Watch this video and ensure you are complying with all 4 measures:

1. Maintain social distancing.
2. Wash your hands.
3. Practice respiratory hygiene.
4. Do not touch your face.

- Remain inside your home. Leave your home **only** for essential activities (e.g. medical care, purchase food).
- Always try to maintain a distance of at least 1.5 meters from all other persons.
- Wash your hands frequently. An alcohol-based hand rub is also effective
- Do not touch your eyes, nose or mouth.
