THAILAND SITUATION IN THE PAST 24 HOURS

SPOTLIGHT

- On the 20th of May 2020, one new case of laboratoryconfirmed COVID-19 was announced by the Ministry of Public Health of Thailand (MoPH) bringing the total number of cases to 3,034.
- Of these, more than 95%

 (2,888) have recovered, about
 1.8% (56) have died and
 about 3% (90) are receiving treatment.
- The new case is in a person who had worked as a chef in
 - a Thai restaurant in Bahrain, who returned to Thailand on 15th May and was held in state quarantine.
- To date, 166 confirmed cases have been found in people who were held in venues arranged for state quarantine, the majority of which were reported in Songkhla.
- Approximately 400 Thai nationals are expected return to Thailand from Brazil and Russia and will be held in state quarantine.
- No new deaths were reported today.

Testing

- As of 15th May, 328,073 samples had been tested for COVID-19.
- As of 17th May, 167 laboratories had been certified by the Department of Medical Sciences for COVID-19 testing.


Vaccine

The Prime Minister aims for Thailand to be one of the first countries to develop a COVID-19 vaccine.

Chulalongkorn University, in collaboration with the National Vaccine Institute and Department of Medical Sciences is preparing for mRNA vaccine experiments in monkeys next week.


Inspection of businesses/activities by monitoring teams

- To date, the government has inspected a total of 301,261 sites for the adherence to public health and social measures.
- Of the 17,588 sites inspected on 19th May, five were found to be non-compliant and 1,863 were not fully compliant, particularly with regard to physical distancing.



- The CCSA advised that participation in the Thai Chana platform is voluntary. It is for the benefit of business establishments, clients and society at large.
- Cumulative data as of 19th May show an increase use of the Thai Chana platform i.e. 67,904 outlets have registered via www.ไทยชนะ.com and 5,077,978 people have used this platform.
- The Department of Disease Control (DDC) is the only user of the Thai Chana data. Data will be kept for 60 days for retroactive tracing purposes. This is based on an assumption of 4 generations of transmission (i.e. 14 days incubation period x 4 generations = approx. 60 days)

To prevent COVID-19 it is safest to avoid physical contact when greeting. Safe greetings include a wave, a nod, or a bow.

How should I greet

This week saw more relaxation of restrictions to curb the spread of COVID-19 in Thailand.
