Robert Muggah is an internationally recognized specialist on international security, public safety, smart cities. He co-founded the Igarapé Institute - a think and do tank working on data-driven safety and justice across Latin America and Africa. He also co-founded the SecDev Foundation and Group - organizations devoted to cyber-security and stability in the Middle East and Eurasia, and South Asia regions. He is a regular consultant to the UN, IADB, World Bank and several firms ranging from Google to McKinseys. Between 2000-2011 he was research director of the Geneva-based Small Arms Survey.

He has authored dozens of peer-review articles and written and edited seven books on cities, arms control, stability operations, refugees, and the rise of digital gangs and cyber cartels. Robert publishes regularly with the Guardian, El Pais, Foreign Affairs, Globe and Mail, o Globo, LA Times, New York Times, Wired and is a speaker at the Chicago Council, World Economic Forum (Davos), and TED in 2015, 2016 and 2017.
