# Technical inputs to WASH accounts materials, trainings and country support, to the GLAAS 2024/2025 cycle and to SDG 6 monitoring

**Area of expertise:** WASH accounts materials and tools, trainings and country support; GLAAS 2024/2025 survey, country implementation, data and reporting; SDG 6 data and reporting

**Purpose of the TORs:** To provide technical inputs to development of WASH accounts materials and the WASH accounts production tool, WASH accounts trainings, WASH accounts country support in English, the update of the GLAAS country survey and eGLAAS and related documents and trainings, country implementation of the GLAAS cycle, GLAAS cycle data and reporting and SDG reporting

### **Background**

The WASH sector has two main tools for monitoring WASH investments and WASH systems hosted by the WHO Water, Sanitation, Hygiene and Health (WSH) unit:

- The Global Analysis and Assessment of Sanitation and Drinking-Water (GLAAS), which provides
  policy- and decision-makers with a comprehensive global analysis of investments and the
  enabling environment for WASH; and
- The development of WASH accounts to track financing to WASH at the national and subnational levels based on the TrackFin methodology.

WHO has continued to expand activities related to GLAAS and WASH accounts in response to increasing demand from countries and global partners.

In the last GLAAS cycle 124 countries participated and more are expected for the next GLAAS cycle to be launched in April 2024. This requires intensive technical inputs for an updated GLAAS survey including eGLAAS and related materials, country trainings/orientations, country implementation and quality reviews and data analysis and reporting.

There are currently over 20 countries developing WASH accounts, with more countries requesting support to launch WASH accounts or to implement new cycles of WASH accounts. WHO (GLAAS) also needs technical inputs to developing new WASH accounts materials, updating existing materials, and ongoing development and improvements to the WASH accounts production tool (WAPT). In addition, countries need expert technical inputs to support their development of WASH accounts including training and capacity building.

# Deliverable 1. WASH accounts training materials, up-to-date WASH accounts community of practice (CoP), WASH accounts document management

### Tasks:

- 1.1: Develop WASH accounts materials including technical notes in English
- 1.2: Update WASH accounts materials as requested, including the WASH accounts implementation guide
- 1.3: Manage and update graphics, contribute to WASH accounts document management
- 1.4: Monitor and manage the Community of Practice (CoP) for WASH accounts

## Deliverable 2: Technical inputs for updated/improved WAPT

- 2.1: Participate in regular meetings with developers and develop information, mock-ups and technical details for updated features and functionalities for the WAPT
- 2.2: Test new versions of the WAPT to validate; undertake testing to verify bugs and issues
- 2.3: Respond to user issues and coordinate links with developers to resolve issues
- 2.4: Update the WAPT user guide

## Deliverable 3: Technical inputs for WASH accounts national and global consultant trainings and stakeholder/partner meetings

3.1: Contribute to preparation, materials, presentations and agendas for national consultant trainings (cohort trainings), and global consultant capacity building and trainings

3.2: Contribute to preparation, materials, presentations and agenda for WASH accounts stakeholder and partner meetings.

- 4.1: Prepare and implement training sessions and training workshops for assigned countries
- 4.2: Undertake technical reviews 1,2 and 3 and documentation feedback for all assigned countries
- 4.3: Monitor country progress for assigned countries, liaising with Focal points and WASH accounts team, and ensuring delivery of WASH accounts ptstudies, WASH accounts highlights and other final products

## Deliverable 5. Updated GLAAS country survey, eGLAAS and training materials for GLAAS 2024/2025 cycle

- 5.1: Provide technical inputs to the finalization of the GLAAS country survey (by 31 March 2024)
- 5.2: Develop and finalize an eGLAAS version of the 2024 survey
- 5.3: Participate in meetings on technical aspects of eGLAAS, coordinate testing/validation of eGLAAS
- 5.4: Update and finalize training materials for the eGLAAS platform for 2024 and provide inputs to the updated GLAAS country survey guidance document

## Deliverable 6. Country training, technical inputs for the 2024/2025 GLAAS cycle, and data analysis and content for the GLAAS report

- 6.1: Facilitate GLAAS trainings for the 2024/2025 cycle across WHO regions in English
- 6.2: Undertake quality assurance reviews of completed GLAAS country surveys and data, and coordinate review of the GLAAS country highlight, from up to 30 countries, in English
- 6.3: Undertake quality assurance review of eGLAAS for assigned regions/countries
- 6.4: Undertake data analysis in requested areas to identify key messages and conclusions for the GLAAS report
- 6.5: Develop content as requested for the GLAAS report
- 6.6: Review and provide feedback on requested content of the GLAAS report
