WHO's main function is to act as the directing and coordinating authority on international health work.  The World Health Organization (WHO) is dependent on the budgetary and extrabudgetary contributions it receives for the implementation of its activities. Bidders are therefore requested to quote the best and most cost-effective solution to meet WHO requirements, while ensuring a high level of service. 5.	Eligible bidders	Bidders shall have the legal capacity to enter into a binding contract with WHO. All WHO suppliers must abide to the UN Supplier Code of Conduct, which is available at the following link: UN Supplier Code of Conduct In addition, bidders shall submit a signed Self Declaration form, included in this ITB. # 1. Purpose

The World Health Organisation (WHO) China Office is seeking a vendor to provide meeting venue, rooms, equipment and services to facilitate the 2025 Beijing Smoke-Free Cities Symposium.

#### 2. Background

The 2025 Beijing Smoke-Free Cities Symposium is scheduled to take place from October 31 to November 1, 2025, in Beijing, co-hosted by WHO China and other partners.

To ensure the smooth running of the event, a suitable venue and accommodation are required. Professional meeting services, including equipment, basic stationery, tea breaks and meals, are also needed to support effective discussions in a proper and well-equipped setting.

#### 3. Planned timelines

Start date: 15/09/2025 End date: 14/11/2025

#### 4. Work to be performed

The chosen vendor shall perform the following activity, in collaboration with WHO China, upon the countersigned contract:

**Provide a professional meeting environment** for a two-day symposium (Day 1: Full-day meeting for 200 participants; Day 2: Half-day morning session for 100 participants), including:

- Meeting room(s) with appropriate layout
- LED screen, microphones, sound system, and technical support
- Basic meeting stationery, bottled water, and on-site professional meeting services

#### **Catering Services:**

- Lunch buffet and tea breaks (one per half-day):
  - o Day 1: 200 participants
  - Day 2 morning: 100 participants
- Dinner buffet:
  - Day 1: 150 participants
  - Day 2: 30 participants

#### **Accommodation:**

Three nights of accommodation for 25 guests, including daily breakfast

#### **Parking Support:**

Parking vouchers should be provided in a reasonable proportion to the number of participants

### 5. Technical Supervision

The selected supplier will work under the supervision of the Technical Officer, Tobacco-Free Initiative, WHO China

#### 6. Inputs

The technical team of Tobacco-Free Initiative in WHO China will guide the contractor on detailed meeting arrangements.

#### Experience required:

Proven track record in delivering high-quality meeting and event services for international conferences of a similar scale in recent years

#### Language requirements:

Bilingual service capacity in both English and Mandarin Chinese throughout the event

- Strong understanding of cultural sensitivity and international hospitality standards
- Ability to provide diverse and healthy food options, with attention to dietary restrictions (e.g., vegetarian, halal, gluten-free)

- Capability to ensure smooth logistics and coordination across all event components
