Executive Director of SHISUK a national NGO has been working on community development and sustainable agriculture since its inception in 1994, has pioneered Community based collective enterprise initiative on floodplain Aquaculture.

SHISUK has awarded National Gold medal by The Ministry of Fisheries and Livestock in 1999 as the pioneer of the Community Enterprise model for floodplain. Selected as Best Practice for Livelihood development by South Asian Association for Regional Cooperation (SAARC) in 2007. Due to aquaculture multiple benefits are raised like, less ground water draw for irrigation in crop cultivation, more ground water recharge, less pest manifestation/ less pesticide use, improved soil fertility due to residuals of fish meal and droppings/ less chemical fertilizer use, strengthen social cohesion, local governance, collective decision making, increased nutrition intake, improved gender relation and women empowerment and sustainable community development.
