



INDIA SITUATION


• There is a decline in number of cases since last week though India accounts for 28% of new cases reported in the world.





COVID-19: STATUS ACROSS STATES

• In the past week (2-8 June), as compared to previous week (26 May – 1 June), all states/UTs have shown a decrease in cases. Higher decrease reported from Uttarakhand (-65%), Rajasthan (-64%) and Delhi (-60%).

- In **Punjab**, Chief Minister virtually inaugurated a 50-bed pediatric COVID care ward, in CMC Hospital, Ludhiana in preparation for the third wave of the pandemic
- In Maharashtra, the government has put a cap on cost of treatment for mucormycosis in private hospitals
- In **Tamil Nadu**, a technical committee to review and monitor the rising incidence of Multisystem Inflammatory Syndrome in Children (MIS-C) has been established

WHO COUNTRY UPDATE

Coordination

- WHO field teams participated in meetings regarding COVID-19 surge, third wave, response and preparation, vaccination; chaired by Chief Ministers, Health Ministers, Chief and/or Health Secretaries, MDs NHM, etc in Andhra Pradesh, Delhi, Karnataka, Kerala, Puducherry, Rajasthan, Tamil Nadu, and UP
- Around 70 tents for setting up auxiliary health facility has been received by **Maharashtra**, **Assam**, **Odisha**, **Jharkhand and Bihar**. States are setting up the tents with guidance from WCO.
- WCO continues to provide technical support to MoHFW, NCDC, ICMR and NDMA at the national level and through task force/control rooms at the state and district level in Andhra Pradesh, Karnataka, Kerala, Tamil Nadu, Telangana, and Puducherry

COVID-19 vaccination

- WCO is supporting monitoring of vaccination sessions across the country and continues to provide surge support for training, microplanning and monitoring
- Supported training of vaccinators in **Chhattisgarh** regarding proper filling of vaccine utilization reports to better reconcile vaccine wastage
- Assisting **Gujarat** with review of COVID-19 vaccination data and field visits to assess gaps in coverage; 5 districts have been visited so far and observations and recommendations have been shared with the state
- Supporting district level workshops in **Karnataka** on COVID vaccination and AEFI, basis guidelines shared by state on vaccinating those between 18-44 years of age

Contact Tracing, Containment and Surveillance

- Country office continues to provide technical support for COVID-19 containment activities in Uttar Pradesh; field teams also provided supportive supervision to monitor contact tracing; identify containment zones and sharing regular feedback with government health officials on regular basis
- Supporting house to house survey for ILI/SARI in Haryana, Punjab, and UP

Information and Planning

- Assisting Rajasthan and Tamil Nadu with death audits and analysis
- Supporting **Tamil Nadu** with development of guidelines on "preventive maintenance & disinfection procedure of medical equipment (including oxygen concentrators) in health facilities & homes"

IPC.

- Supporting strengthening of ward level taskforce committee on ILI & SARI surveillance in Karnataka
- Supporting district level training for capacity building on IPC protocol, COVID appropriate, and COVID surveillance and contact tracing in **Delhi**


Essential Services

- Efforts to strengthen VPD surveillance and immunization are underway in Andhra Pradesh, Chhattisgarh
 Himachal Pradesh, Tamil Nadu, and Telangana
- Supporting Delhi, Karnataka, Puducherry, and Telangana in strengthening AEFI surveillance
- Supporting **Delhi** with smooth implementation of polio SNID
- Supporting Chhattisgarh, Goa, and UP for roll out of Pneumococcal Vaccine (PCV)

As of 8 June 2021, India has tested more than 360 million samples. Tests include both, RTPCR and Rapid Antigen. India's current test positivity rate (7DMA) is 5.93%.
