Together, we can secure a future where every country has a confident, competent, and supported public health workforce, one that is equipped to counter misinformation, adapt to new challenges, and protect the right to health for all.

Health is not only an outcome; it is the **pillar of resilience** on which our common future depends. Let us invest in those who make that future possible, our public health workforce.
